Membership Development & Education Committee Update - Alissa McIntyre

The Membership Development and Education Committee has been up to quite a lot. Following the start of the new CKI year, we divided the committee into three parts: recruitment and retention, chartering, and member benefits and professional development, each with their own respective specialists (recruitment and retention has two). All of our committee members are so dedicated and passionate that they came fully prepared with a lot of ideas. Through our four specialists, we were able to hit the ground running with some fantastic ideas for International.

We started the year off strong with an immediate collaboration with the Research and Development Committee to help develop questions for their Member Experience Survey; each respective specialist formatted 3 questions to submit and we were able to see most in that survey. Following the survey, our Member Benefits and Professional Development Specialist, Trustee Liaison, and myself were given the honor of presenting at the Wisconsin- Upper Michigan District's Fall Event on topics related to resume building and interview skills. During this time frame, our Chartering Specialist began working on an idea for a chartering panel; we are very excited for this project and plan to see it's completion next semester with a lot of guests who are very educated in the charter process in the hopes of educating others. Our Chartering Specialist also initiated an ongoing collaboration between the Membership Development and Education Committee and the Global Development Committee for the Non-US chartering process. Once we had the door open for that collaboration, we compiled a list of our most important resources as a committee and sent it over to GDC to be translated. After that, our Recruitment and Retention team created a few resources for recruitment in a virtual world, which we are planning to have available next semester.

During the latter part of October, the committee finalized our New Member Orientation Program Presentations, which should be widely available for club use soon, and started creating new ideas for the next month. We are continuing to work on those ideas currently, since they are lengthy in process. One of our ideas, spearheaded by our Recruitment and Retention Specialists was to host a set of value-adding seminars at District Conventions. These

presentations are already made, and we cannot wait to present at the many districts that have invited us already! After this, we started working on a set of promotional graphics for various district and club positions that will be released during the upcoming election season as a way of promoting the positions available. We are also working on a recruitment drive to take place in mid-February that should help pre-convention recruitment and attendance. These will work essentially as a list of challenges and will encourage participation worldwide. And as we wrapped up the semester, we finalized some ideas for collaborations with the CKIx Planning Committee, the Kiwanis Family Relations Committee, the Global Development Committee, and the Finance Committee for the next semester and are very excited to work with them!

Global Development Committee Update - Brandon Ramirez

Committee Chair Projects

1. Research Question Planning: Helping draft questions that would be included in the R&D Committees Report to help us see how we can get CKI members more involved with our International Chapters.
2. Club Highlight Form: Created a google form that would allow for ambassadors and possibly trustees to nominate clubs who have been working hard to gain recognition on CKI social media accounts.
3. CKI Map: Created a Google Map that marks all districts and regions that are encompassed across CKI. The map will be slowly updated over December to primarily include non-US chapters.
4. Directory: Created a directory that will be updated throughout the year to include all methods of contact used by our international clubs. This was a resource that did not exist in the previous term and was created to have a sustainable method of contact collection for future committees to utilize.
5. Italy-San Marino Kiwanis/CKI Meetings: Attending meetings with Italy in an effort to assist KIEF in chartering and actively getting the image of CKI in Europe.
6. Policy Code/Amendments/Finance Discussions: Working with Trustees and other committees to be more inclusive of our international chapters and creating more transparency for dues structures.



Committee Projects

1. Asia Pacific Region
 - a. Taiwan Districting: Sofia has been working with Taiwan to have updated bylaws and final details in preparation to create a new district in CKI.
 - b. Translation: Sofia and Nancy have been working to translate MD&E and GDA documents to share with chapters. They have also been trying to promote the Tomorrow Fund on behalf of the service committee.
 - c. Nepal and Australia: Nancy has been reaching out to Key Clubs and Kiwanis chapters in these regions to see if they have any contacts or resources to start the discussion of chartering new clubs in the area.
2. European Region
 - a. Italy-San Marino Meetings: Sarah has been reaching out to the Kiwanis and CKI Chapters in Italy in an effort to charter and recharter in the region, and help get the CKI image to spread in Europe, as it is not a well-known branch out there.
 - b. Translation: Sarah has been working to translate MD&E and GDA documents to share with chapters. They have also been trying to promote the Tomorrow Fund on behalf of the service committee.
3. Latin America Region
 - a. Facebook Media: Erick has been working with Joey to get a Facebook page established for the LATAM regions to use and have a better sense of connections and contacts that can support one another.

Service Committee Update - Matt Wade

Governing Documents & Awards Committee Update - Leah Reiser

The Governing Documents and Awards Committee has been hard at work this year. Here are a few of the things we have been working on recently:

Chair Projects

1. Myself, Hannah, Joey and Tana met with Jeff and Diana to go over the current Policy Code and Bylaws.
2. Began to explore the idea of having an Advisory Committee to help with the transition of the committee for the next few years.
3. Worked with the Global Development Committee to look over Bylaws for Taiwan
4. Myself and Hannah helped Districts with amendments they would like to propose.

Committee Projects

1. We began to look at the Policy Code and Bylaws to eliminate grammatical errors.
2. Started working on Amendments to the Policy Code to be presented at the January International Council Meeting.
3. Began to restructure the Policy Code which will be presented to the International Board.
4. Began to go through our Bylaws to identify any possible amendments that are needed.
5. Started to create a resource for Districts who will have a Virtual House of Delegates.

7. The point value for awards was changed from 150 points to 100 points for all awards except Club Achievement.
8. Developed Awards Trackers that District Board members can use to keep track of their awards progress.

9. Created the 2020-2021 Awards Manual which covers what has changed for the awards as well as the steps to apply for awards and their due dates.
10. Began to think of ideas for new awards for the 2021-2022 term.
11. Will soon start looking at the Standard Form for Bylaws to make it easier and more efficient for districts and/or clubs to use.

Committee Collaborations

1. There was a collaboration with the Global Development Committee to look over the bylaws for Taiwan.
2. There was a collaboration with the Service Committee to make the Policy Code section regarding Service Hours clearer.
3. There is a current collaboration with the CKI Planning Committee where we are looking at hosting a workshop during their workshop event.
4. We are currently looking at more collaborations with other committees to make sure the Governing Documents accurately reflect the direction that the organization is headed,

Kiwanis Family Relations Committee Update - Annamarie McGuire

Chair Projects

1. Reviewing Old Material from Previous KFR Committees
 - a. Assessing the materials and determining the relevancy of material and if it needs to be added onto the new website
2. Assisting my committee member working on Kiwanis Mentorship Program
 - a. By helping to connect with the districts who were starting the program during last service year
 - b. Discussing and reviewing the materials that already existed for the program from past committees and where resources can be expanded up to propel the program within districts
3. Communication for an Instagram Takeover
 - a. Attended a Key Club KFR committee meeting to discuss the potential of hosting an Instagram takeover

- a. The committee started to weigh the pros and cons of establishing a uniform Kiwanis Family Map to allow clubs to connect with the Kiwanis Family counter parts in their college.
- b. This project did not get started and will be something that the committee comes back to work on after the semester ends in December

3. Tips & Tricks for Hosting a Virtual College Preview


- a. This project was started to help provide tips and tricks for clubs to host a virtual preview of their college and of their club via social media or zoom. This project is looking to help clubs connect with their local Key Clubs and to connect with incoming students to their college.
- b. The committee completed a document outlining tips and tricks of aspects to include in a virtual college preview.
- c. The committee will look forward to completing an outline example of hosting a virtual college preview using zoom and will also design some examples of promotional materials clubs could use to promote their own college/club preview.

4. Key Club Senior Night

- a. The committee immediately brainstormed ideas of what type of presentations and event schedule would be beneficial for hosting and international Key Club Senior Night in the Spring.
- b. The committee has worked to reach out to districts that have hosted district-wide Key Club Senior Nights in the past and gained insight about what did and did not work for their district level events.
 - i. The insight was considered for planning the event schedule for the international event.
- c. The committee has outlined the schedule of events for Key Club Senior Night and has established the potential date for the event in April.
- d. Looking ahead, the committee is looking to divide the work among themselves from designing the presentation, Q&A panel questions and other aspects of the event.

5. Kiwanis Mentorship Program

- a. Resources were established for districts and passed on for review and finalization to help provide building blocks for districts to start their own Kiwanis Mentorship Program

- b. The committee is looking to establish the resources necessary to lay the foundation to establish a version of the Kiwanis Mentorship Program on the international level to connect Kiwanians and Circle K members from around the globe.

 - i. This list is designed to be broken down by Kiwanis Family branches to allow clubs to find ideas of different service projects that they can do both virtually, socially distanced and in-person without restrictions with the individual branches
 - ii. The project is progressing and has completed lists for Key Club, CKI, and Builder's Club already. K-Kids, Kiwanis and Aktion Club project ideas are the next branches that are being looked at to be completed
- 2. Membership Development & Education
 - a. Formstack Questions for Kiwanis Club Sponsorship
 - i. The committee worked to establish a document to help inquire the interest of Kiwanis Club to sponsor CKI clubs not necessarily in their local area.

Finance Committee Update - Amanda Lang

Chair Projects

1. Dues proposal
 - a. Last year's dues proposal recommendation was a club base fee of \$250 + \$12.50 per member fee, with a 100 member cap. The committee is looking towards moving to a more member-based system of \$150 per club and \$15.50 per member, with a 50 member cap.
 - b. Analysis of dues survey responses from last year and creation of R&D survey questions will help with this.
 - c. Charter fees were not considered last year. The current a-la-carte system was analyzed; it was determined that charter fee had little impact on club health. However, it is important to note there was only 5 years worth of data since the a-la-carte system was implemented in 2015.
2. Covid dues town hall held 10/27

Committee Projects

 - a. Drafted survey questions, four of which made it into the R&D all-member survey.
 - b. Upon seeing the questions may not help with the dues proposal, drafted four more to be sent with DEI Task Force questions, and then promoted to DTs.
