RUNNING FROM THE FLOOR

Per CKI bylaws, (Article 12, Section 4) any eligible CKI member can run from the floor at convention. Interested members must meet the eligibility requirements, bring the appropriate paperwork to convention to verify their information and be nominated from the floor at the opening session. Interested members should contact Samantha Wagner (swagner@kiwanis.org) for additional information.

Eligibility Requirements (CKI Policy Code, Section 2, Subsection C):

Must have their name appear on the official CKI membership list;

Must be in good standing with his/her home club;

Must have a home club in good standing with CKI, their home district, and their university; Must have a home district in good standing with CKI;

Must be enrolled at the university of his/her home club, have a minimum cumulative Grade Point Average of 2.5 on a 4.0 scale (or the equivalent) at the time of eligibility certification, and maintain a minimum cumulative Grade Point Average of 2.25 on a 4.0 scale (or the equivalent). Any special considerations may be made by the CKI Director; and, (2/17) Must abide by their completed officer service agreement. (2/17)

If you wish to run from the floor, refer to the candidate packet for required paperwork and important dates. If the paperwork is submitted to Samantha Wagner and approved, the candidate may participate in the virtual Caucus of the Whole prior to the convention.

Required paperwork include:

A copy of your current transcript. (Spring 2025)

A copy of your fall 2025 schedule verifying that the candidate is enrolled in a college/university.



Question #1: What have you learned from your previous experiences that you plan to implement in this role?

Through my leadership experiences in CKI and beyond, I've learned the value of transparency, honest communication, and standing firm in your beliefs. While serving in roles like Recharter President, Lieutenant Governor, District Governor, International Committee Chair, and International Trustee, I've seen how important it is to empower others, not just lead them. A meaningful lesson I carry: Leadership isn't about what the organization can do for me, but what I can do for the organization. These experiences have taught me how to uplift others, create space for new ideas, and always lead with purpose. I plan to carry that mindset into this role – focusing on supporting our leaders, building trust across all levels, and making decisions that move CKI forward with integrity and intention.

Question #2: How do you plan to support and collaborate with the individuals you'll be working with in this role?

Supporting and collaborating across all levels – governors, the international board, CKI staff, Kiwanis leadership, committee chairs, Key Club leaders, and general members – is something I take seriously. I want to be a resource for everyone, someone approachable and reliable, while also being proactive in my leadership. I plan to strengthen collaboration by helping ease the burdens placed on others, especially the international board and district leadership, through reducing redundancy and streamlining expectations. A big part of that includes continuing to deeply reassess our current administrative procedures and looking closely at what's actually effective and what isn't. By working closely with staff and Kiwanis, I hope to make the behind-the-scenes processes more efficient, so we can focus on serving our members and moving CKI forward.

Question #3: What strategies would you use to grow CKI membership at the international level?

Growing CKI internationally starts at the club level. I believe deeply in the power of ground-based recruitment; the board needs to be more hands-on. We should be on the frontlines of chartering, helping new presidents build personalized plans, and providing standard growth tools like meeting guides, tabling tips, and accessible resources. Most importantly, I see myself first and foremost as a general member. I plan to keep recruiting one-on-one, just like I did when I grew my home club from 3 to 65 members in one year. That strategy works, and it's something many of us on the board are strong at. We need to lead by example—visiting struggling clubs, tabling on new campuses, and showing what true, student-led action looks like.

Question #4: Why do you feel like this is the best position for you?

I am here to MAKE THINGS HAPPEN, as I've proven I'm dedicated to doing. I want to create meaningful change on behalf of the entire organization, and this role gives me the platform to do exactly that. I've led at every level: rechartering a club from scratch, growing it to the largest in the district, serving as LTG and Governor, launching a fundraiser raising over \$75,000 for UNICEF, chairing an international committee, and helping charter (at the time) the only active CKI club at an HBCU. I've planned events, led workshops, and presented across the country. I know the ins and outs of this organization and the responsibility this role holds. I'm ready to lead with purpose, urgency, and action. CKI deserves nothing less.

Question #5: If you could only accomplish one thing during your term, what would you accomplish and why?

If I could accomplish only one thing during my term, it would be proving to Kiwanis that CKI is worthy of deeper investment and trust. Strengthening that connection is vital, not only for the future of CKI but for Kiwanis as well, as we are their pipeline of future leaders. I believe this starts with showing that we are capable, serious, and ready to lead. I know I have the experience and confidence to walk into those rooms and have honest, forward-thinking conversations – even when they're tough. If we want CKI to thrive, we need to advocate for ourselves at every level, and I'm ready to be the one who stands up, speaks clearly, and proves just how much our organization is worth.

Question #3: What strategies would you use to grow CKI membership at the international level?



Question #1: What have you learned from your previous experiences that you plan to implement in this role?

I also aim to restructure our internal operations and the number of meetings conducted, helping to find new ways to boost engagement and retention, ensuring every member feels valued and connected. These lessons will help guide my approach to creating a more supportive experience for all members.

Question #2: How do you plan to support and collaborate with the individuals you'll be working with in this role?

In this role, I plan to prioritize open communication, active listening, and mutual respect when working with individuals across the organization. Question #1: What have you learned from your previous experiences that you plan to implement in this role?

I have been fortunate to serve on the Illinois-Eastern lowa district board for three years. I have served in two chairperson roles as well as district governor this past year. Furthermore, I was UIUC CKI club social chairperson and had four years of service in key club. Each role had unique lessons that led me to where I am today. In particular, my time as Governor was full of hard decisions that required a careful balance between what was expected of me and what the individual club leaders I worked with needed. The scope of my impact to employ fellowship as trustee would be limited, but I know that there would be fruitful conversations with governors to help their districts and for me to help others. Question #1: What have you learned from your previous experiences that you plan to implement in this role? As club President and District Governor, I focused on empowering members, fostering collaboration, and promoting leadership development. As District Governor, I led initiatives that grew membership by 99%, from 91 to 181 members in one year, helped transition the district to full status, and hosted in-person DCON events for the first time since 2019.
